


LGBTQ YOUTH ARE OVERREPRESENTED IN THE CHILD WELFARE SYSTEM

Some LGBTQ youth experience family rejection and family instability. Research finds LGBTQ youth are more likely to be involved in the child welfare system.

LGBTQ YOUTH EXPERIENCE HARASSMENT & VIOLENCE

In the child welfare system, LGBTQ youth experience discrimination, harassment, and violence from peers and staff. This includes attempts to "change" their sexual orientation through the of conversion therapy or refuse to acknowledge their gender identity.


LGBTQ YOUTH MORE LIKELY TO ENTER JUVENILE JUSTICE SYSTEM AND EXPERIENCE HOMELESSNESS

LGBTQ youth are 120% more likely to experience homelessness and are more likely to "crossover" to the juvenile justice system. Nearly all LGBTQ youth in the juvenile justice system are youth of color (85%). LGBTQ youth are more likely to be detained and to experience sexual assault in juvenile justice facilities than their peers.
