- Users must Register to perform a Smart Search.



- A Record (Case) Number or Name is required for all searches.
 - Case numbers can be searched as 2019CV25 or RL2020CV50 depending on date filed. Refer to the Case Number Format section on page 4.
- Select the ? to display search tips.

- Check the **I'm not a robot** reCAPTCHA box and verify before selecting **Submit**.
- Select **Advanced Filtering Options** to reveal additional case search options.

Note: Converted documents from any case management system used before Odyssey are **NOT** available on the Public Portal search from the web. Public converted documents are available on the Courthouse Terminal (Kiosk).

Advanced Filtering Options:

General Options

- **Filter by Location** – Use the drop-down arrow to select All locations or an individual county.
- **Filter by Search Type** – Options include Smart Search, Attorney bar number, attorney name, business name, case cross reference number, case number, citation number, judicial officer, nickname and party name.

Party Search Criteria

- **Search by** – Party name, Business name, Nickname or Sounds Like. Business name must be checked if searching for a business.
- **Date of Birth From, Date of Birth To, KBI Number, SO Number, or Booking Number** are additional party search criteria fields.

Case Number Format for Cases Created in Enterprise Justice Odyssey

All Kansas counties are currently using the Enterprise Justice Odyssey Case Management System.

Any case that is initiated in the Enterprise Justice Odyssey Case Management System will have a new case number format. The case number format will begin with the county abbreviation followed by the four-digit year, case type abbreviation, and the six-digit case number.

Example: a Criminal case filed in Riley County would have a case number of RL-2019-CR-000001.

Cases initiated in the counties of Clay, Dickinson, Geary, Marion, Morris, and Riley counties prior to **August 5, 2019**, will have the case number format of Year, Case Type abbreviation, and case number of 6 digits.

- Example: a Criminal case filed in Riley County prior to August 5, 2019, would have a case number format of 2019-CR-000001.
- Example: a Criminal case filed in Riley County after August 5, 2019, would have a case number of RL-2019-CR-000001.

Cases initiated in the counties of Allen, Anderson, Bourbon, Chautauqua, Cherokee, Coffey, Cowley, Crawford, Franklin, Labette, Linn, Marion, Miami, Montgomery, Neosho, Osage, Riley, Wilson, and Woodson Counties prior to **November 2, 2020**, will have the case number format of Year, Case Type abbreviation, and case number of 6 digits.

- Example: a Criminal case filed in Allen County prior to November 2, 2020, would have a case number format of 2020-CR-000001.
- Example: a Criminal case filed in Allen County after November 2, 2020, would have a case number format of AL-2020-CR-000001.

Cases initiated in the counties of Butler, Elk, and Greenwood counties prior to **November 1, 2021**, will have the case number format of Year, Case Type abbreviation, and case number of 6 digits.

- Example: a Criminal case filed in Butler County prior to November 1, 2021, would have a case number format of 2021-CR-000001.
- Example: a Criminal case filed in Butler County after November 1, 2021, would have a case number format of BU-2021-CR-000001.

Cases initiated in the counties of Barton, Brown, Chase, Cheyenne, Cloud, Decatur, Doniphan, Ellis, Ellsworth, Gove, Graham, Jackson, Jefferson, Jewell, Lincoln, Logan, Lyon, Marshall, Mitchell, Nemaha, Norton, Osborne, Ottawa, Phillips, Pottawatomie, Rawlins, Republic, Rice, Rooks, Russell, Saline, Sheridan, Sherman, Smith, Stafford, Thomas, Trego, Wabaunsee, Wallace, and Washington Counties prior to **July 11, 2022**, will have the case number format of Year, Case Type abbreviation, and case number of 6 digits.

- Example: a Criminal case filed in Barton County prior to July 11, 2022, would have a case number format of 2022-CR-000001.
- Example: a Criminal case filed in Barton County after July 11, 2022, would have a case number format of BT-2022-CR-000001.

Cases initiated in the counties of Atchison, Barber, Clark, Comanche, Edwards, Finney, Ford, Grant, Gray, Greeley, Hamilton, Harper, Harvey, Haskell, Hodgman, Kearny, Kingman, Kiowa, Lane, Leavenworth, McPherson, Meade, Morton, Ness, Pawnee, Pratt, Reno, Rush, Scott, Seward, Stanton, Stevens, Sumner, and Wichita Counties prior to **September 12, 2022**, will have the case number format of Year, Case Type abbreviation, and case number of 6 digits.

- Example: a Criminal case filed in Atchison County prior to September 12, 2022, would have a case number format of **2022-CR-000001**.
- Example: a Criminal case filed in Atchison County after September 12, 2022, would have a case number format of **AT-2022-CR-000001**.

Cases initiated in the counties of Douglas, Shawnee, and Wyandotte Counties prior to **April 7, 2023**, will have the case number format of Year, Case Type abbreviation, and case number of 6 digits.

- Example: a Criminal case filed in Douglas County prior to April 7, 2023, would have a case number format of **2023-CR-000001**.
- Example: a Criminal case filed in Douglas County after April 7, 2023, would have a case number format of **DG-2023-CR-000001**.

Cases initiated in Sedgwick County prior to **August 3, 2023**, will have the case number format of Year, Case Type abbreviation, and case number of 6 digits.

- Example: a Criminal case filed in Sedgwick County prior to August 3, 2023, would have a case number format of **2023-CR-000001**.
- Example: a Criminal case filed in Sedgwick County after August 3, 2023, would have a case number format of **SG-2023-CR-000001**.

Cases initiated in Johnson County prior to **October 28, 2024**, will have the case number format of two-digit year, Case Type abbreviation, and case number of 5 digits.

- Example: a Criminal case filed in Johnson County prior to October 28, 2024, would have a case number format of **24CR00001**.
- Example: a Criminal case filed in Johnson County after October 28, 2024, would have a case number format of **JO-2024-CR-000001**.
